## UNDERINSURED AND UNINSURED MOTORIST INSURANCE PROTECTION A WHY YOU NEED IT



## SETTLEMENT REACHED FOR FAMILY OF MAN KILLED DUE TO AIR B FAILURE

substantial settlement for a family against General Motors, one of the world's largest car manufacturers. The settlement brings a favorable end to the family's wrongful death lawsuit seeking compensation for the serious, life-changing injuries, and the death of the driver, a loving husband and father, who received fatal injuries, when his driver's side air bag failed to deploy upon impact.


In October of 2012, the driver and his family were traveling in their Chevrolet Trailblazer on the highway in Eagle Pass, Texas. At the same time, a truck tractor pulling a flatbed was traveling in the opposite direction. Suddenly and without warning, the driver operating the truck tractor made a quick left turn, striking the Trailblazer from the side. Upon impact with the negligent driver in this case, the driver's side air bag failed to deploy.
