ABRAHAM WATKINS FIRM NAME CHANGE

In 1951, three young friends, Frank Abraham, John Hill, and W. James, Kronzer, Jr. founded the firm Hill, Kronzer and Abraham. About a year later, J. Curtiss Brown joined the firm and it became Hill, Brown, Kronzer and Abraham. Will Watkins and Bob Steely eventually joined the

firm and when they became partners, the firm became Hill, Brown, Kronzer, Abraham, Watkins and Steely. Since the firm's early days, the firm name has changed multiple times to recognize the attorneys who have risen into a significant role of leadership. Effective November 1, 2016, Abraham, Watkins, Nichols, Sorrels, Agosto & Friend became Abraham, Watkins, Nichols, Sorrels, Agosto & Aziz. The firm congratulates Mo Aziz on becoming a named partner and proudly welcomes Aziz to the firm name.



Mr. Aziz is a prominent trial attorney in the local and national legal community. He has a diverse background, growing up in Pakistan and attending the University of London for his undergraduate studies. Mr. Aziz moved to the United States in 2001 to attend the University of Houston Law Center and has been practicing law in Houston ever since. NEW ASSOCIATE JOINS ABRAHAM WATKINS



TAKATA AMMONIUM NITRATE AIRBAG CAUSING 10TH DEATH REACHES SETTLEMENT

Firm Partner Mo Aziz has reached a confidential settlement on behalf of the parents of 17-year-old Huma Hanif who was killed on March 31, 2016 by the defective airbag system in her 2002 Honda Civic. The wrongful death lawsuit, filed in Harris County against TK Holdings, Inc., American Honda Motor Co., Inc., and the dealership that sold the vehicle, settled against all parties for the defective design, marketing, manufacturing, testing, and distribution of the vehicle and its accompanying airbag system. Mr. Aziz filed suit on April 26, 2016, and the post settlement dismissal order was signed on November 7, 2016.



On March 31, 2016, Huma Hanif was involved in a motor vehicle accident in Fort Bend County. Upon impact, the ammonium nitrate in her airbag detonated, causing the inflator to fragment and metal shrapnel to be forced through the airbag. The metal fragments struck Huma in the neck, killing her. This was the 10th fatality in the United States resulting from an exploding Takata airbag inflator. 
GOLF CART EJECTION FATALITY CASE REACHES SETTLEMENT



Firm Partner Benny Agosto, Jr. has reached a confidential settlement on behalf of the family of Ronald Burdick for the fatal injuries Mr. Burdick sustained after being thrown from a golf cart at the Dolce Living Rosenberg property on May 7, 2015. After being hospitalized at Memorial Hermann Hospital for eight days, Mr. Burdick did not survive his injuries and died on May 15, 2015.

Following their move from Alaska to Texas to be closer to their children and grandchildren, Mr. Burdick and his wife visited the Dolce Living Rosenberg property in search of a new apartment. The leasing agent offered to show the couple a few different model apartments using the property's golf cart, which was frequently used to travel within the apartment complex. Mrs. Burdick sat in the front seat with the leasing agent, while Mr. Burdick sat in the rear seat. The leasing agent reversed the golf cart and began driving towards one of the property's gates, when suddenly and without warning, she made an unexpected tight left turn, ejecting Mr. Burdick from the golf cart and onto the

pavement. Mr. Burdick suffered a serious brain injury as a result of the forceful fall and died days later. [Learn More](#)
